Men's Contest includes person to eat 10 hot dogs and buns in the fastest time possible and Women's Contest includes person to eat 5 hot dogs and buns in the fastest time possible, the only beverage is water, which will be provided.

Contestants will wait for the whistle to start - contestants timed with a stopwatch.

All hot dogs and buns are to be completely swallowed.

Dunking and crunching the hot dog bun is permitted.

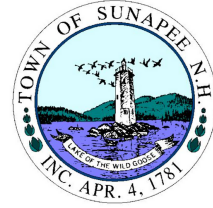
Separating the hot dog and the bun is permitted.

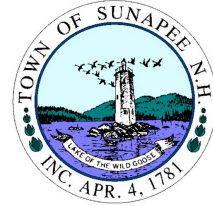
